10-Year Limited Warranty – Sleep Calm™ + Pillow Protector

Sleep Calm + Pillow Protector is warranted against defects in workmanship or materials for a period of 10 years from purchase. Subject to the terms hereof, Leggett & Platt (“L&P”) will replace at no cost to the original retail purchaser (the “Customer”) any defective Sleep Calm + Pillow Protector.

To qualify for Limited Warranty coverage, a claim must be submitted on or before the 10th anniversary of the date of purchase and using the following procedure:

1. Customer should launder the Sleep Calm + Pillow Protector as soon as possible after the incident occurred, following recommended care instructions;
2. Customer must register the claim within 5 days of incident by calling 1-800-233-7225;
3. Customer must send, at Customer’s expense, the damaged protector to L&P for inspection and validation of claim;
4. The Sleep Calm + Pillow Protector must be in good condition (e.g., free from any rips, tears, or burns);
5. The Sleep Calm + Pillow Protector, a copy of THIS WARRANTY CARD, and a copy of the purchase receipt showing the date of purchase of the Sleep Calm + Pillow Protector must be sent to L&P at the address below.

L&P will ship a replacement Sleep Calm + Pillow Protector at L&P’s expense upon receipt of the above items and validation of claim.
